

Herbal Extract  
August 1991

Years ago I had cancer of the bone, stomach, groin, lymph node and my eyes. I also had rheumatism, asthma, and bronchitis and fungus growth on my feet that I picked up in the South Pacific. Consequently, I really wasn't a very good candidate for any Olympic team. I sought out many different herbal physicians and herbalists and an old Navajo Indian medicine man. I purchased numerous different herbal formulas from them and used them orally daily. Several years later my medical problems were in remission.

However, I was concerned about the possibility of my diseases reactivating. Consequently, I began studying everything about herbs from many sources and every aspect of their chemical active ingredients, different formulations, and their healing and/or toxicity, attributes, etc. I concentrated some of my early studies and efforts on acquiring the old writings, teachings, and manuscripts of the very ancient herbal physicians. When needed I would have them translated in to English. I studied the ancient Greeks, Israelites Arabs, Egyptians, Chinese, and Hindus, the old Romans, Europeans, Mayans, Africans, Asians, primitive tribes and most modern herbalists. Even today 75% of the world's population still relies on plants and plant extracts for their ability to heal disease. At the same time I had been studying the causative of diseases. I concentrated my early studies on what European and other medical research centers were learning and discovering. I have no titles or degrees of any kind, nor am I seeking any. I consider myself self taught. I owned numerous income producing businesses, therefore I was able to afford the costly research that was and is being done on my behalf to develop and improve the herbal extract.

I acquired a small laboratory and began formulating numerous old and new herbal compounds. These would be applied topically to the diseased areas of the epidermis (skin) of many different species of animal and some selected humans including myself. When a particular compound would cause an escharotics reaction it would be sent to a bio-technological laboratory for further testing, and analyzing mostly in vitro (glass). After testing numerous different herbal compounds several were discovered whose organic and inorganic molecules had an affinity for and was cytotoxic to all pathogenic micro-organisms (antigens and pathogens), cancer cells, and pathological (diseased) self cells "only". The herbal molecules would not bind to normal healthy body cells, animal or human. Among other things we learned that the efficacy of the compounds was caused by selective electrostatic chemical interactions and ionic differences between the organic, inorganic molecules in the compounds and pathogens, cancer cells, diseased cells and non-diseased cells. The mitochondria of diseased cells "only" was also involved, under certain conditions the mitochondria would absorb the compound molecules and destroy the mitochondria and any RNA or DNA within the disease cells membrane.

Several of the more active compounds then went through a period of numerous reformulations, testing and improvement programs and more experimental topical applications to animals and humans. Some of the ensuing results were often dramatic. The compounds were applied to basal and squamous cells, melanoma, fibromas and other

cancers -- Viral caused infectives, bacteria caused infectives, both Gram-positive and Gram-Negative (bacterium), infected cysts, fibroid tumors, fungal growths, viral warts, diseased muscle, connective tissues, bone, and organs. Within a few days after application the disease area would become red and inflamed, painful pus with traces of blood would seep, and after the entire diseased area had sloughed off, it scabbed over and lysis began. Tissue, bone, and organ cell replacement and self repair from within and from the outer edges would commence. In most cases, diseased areas would (within 30 to 60 days) return to normal pre-diseased appearance. Larger areas would take longer, very little scarring was evident.

We learned that if the disease had penetrated from the epidermis to the dermis, muscle, connective tissue, bone or organs, and was contiguous and after the compound was applied to the epidermis several times it would follow the disease any were else in the body. However, due to the severe pain and other reactions it is not recommended that the compounds be applies topically to humans unless sufficiently diluted with water. The next phase of development was to use the compounds by oral ingestion and I.V. on animals, and later humans.

A long period of research to determining correct dosages was started. Monitoring and testing by biochemists, pathologists, biologists, veterinarians, and others, of all vital body chemistry and functions were done. Among other things, urine and fecal matter, WBC (white blood cells) RBC (red blood cells) platelets and many other components and elements of the blood were analyzed and tested. Tissue, bone and organ sections were pathologically examined. Endocrine hormones, other chemicals, and metabolics were tested. Different antigen tests and other disease indicator tests were utilized. All molecule elements and components of the entire immune system were monitored quite frequently. They included, but were not limited to, the following: T-4 helper cells, T Natural killer cells, T-8 suppressor cells, esinophils, monocytes neutrophils, basophils, phagocytes, immunoglobulins, monokines, cytokines, interleukins, and complement proteins.

Professional users of the extract have also done much research and clinical testing of the extract. Doctors, nutritionists, veterinarians, and other health professionals have used the extract on themselves, their family, patients, clients, and animals. Their laboratory results and clinical patient usage have also confirmed our earlier conclusions and results.

Among other things we learned that the extract was not toxic to beneficial bacteria of the gastrointestinal tract. The extract, when absorbed into the blood and lymph system from the intestinal tract would usually after 7 to 10 days prevent metastasis of cancer cells. When the extract molecules encountered any pathogen, cancer cells or diseased cells in the blood, lymph, epidermis, dermis, organs, bone, muscle and other tissue anywhere in the body the extract would bind to them and eradicate them. In some instances the cytotoxic molecules of the herbal extract seemed to have a greater affinity for pathogens, cancer cells and diseased cell that are labeled immunoglobulins. When the extract was lysis (eliminating) any diseased areas in any part of the body there was a

period of some inflammation and usually moderate pain. Where there was a larger diseased area, there was more pain and inflammation and a longer lysis cycle, usually 4-6 months. Some would experience slight fever and/or flu like symptoms. All of the skin diseases healed by topical use of the extract were eradicated by oral ingestion of the extract.

When the user of the extract is eliminating all species of intracellular parasites from the gastro-intestinal tract or eradicating the causes of colitis, diverticulitis, crones, polyps, proctitis, hemorrhoids or cancer the patient will experience an increase in intestinal flatulence (gas), diarrhea, bloating, pain, and stools may change colors and become very odorous. This reaction usually last one to several weeks.

Rashes, hives, eczema, psoriasis, herpes, shingles or other similar infectives; Those who had pathogens that were active or were in remission their disease symptoms might be exacerbated or be re-experienced again for a few days or weeks and then go into permanent remission, providing the extract is taken continuously for 3 to 4 months or longer.

Much published research information by others links auto-immune diseases and allergies to a defect in the immune system. When T-8 suppressor cells are low in number they fail to suppress certain antibodies from labeling or marking healthy self cells. This labeling causes the macrophages and neutrophils to mistakenly attack the self cells as an antigen.

The extract normalizes molecular elements and components of the immune system, consequently the progress of auto-immune diseases is terminated and its harmful effects are usually reversed and corrected over a period of time. Major causes of damage to T-cells, thymus gland and other element of the immune system are pathogens, certain pharmaceutical drugs, physical damage to the thymus from radiation operations and accidents. Some thymus gland damage cannot be over come by the extract. Also, as we age the thymus reduces in size and efficacy. Some elderly people who use the extract consistently and have had thymic hormone and T-cell tests report that their thymus gland seems to be rejuvenated or stimulated to produce more thymic hormones and T-cells and eventually their immune functions normalize.

Multiple sclerosis MS (an auto-immune disease) in many instances those in the early stages of MS have much improvement or total remission. Others who are in wheelchair condition, their improvement is slow to none. Reactions to the use of the extract are pain, tingling sensations or numbness. There is no conflict with using the extract with any medication.

Rheumatism and or Arthritis (an auto-immune disease) Remission or improvement is approximately 90%. Reactions in most instances to using the extract are some pain and swelling in the joints and muscles for 30-60 days. When the adverse symptoms are eliminated then a long term maintenance dosage is recommended.

Leukemia and other blood cell diseases: The extract usually normalizes RBC, WBC, and platelets in 60 days or more. However, no one who used the extract for controlling these diseases has ever quit using it, so the permanence of the remission after discontinuing the extract is no known. Some have been on the extract for 7 years. One 73 year old mans' WBC has been abnormally high for more than 5 years. However, his RBC and platelets are normal. Yet, he is healthy, works everyday and feels good and has much energy. No noticeable reactions when using the extract for theses disease.

Cancer: Approximately 79% of all cancers develop in people after they reach the age of 55. In the past 20 years or more years, 477 individuals have successfully used the herbal extract for all minor and major cancers including brain tumors and other brain infectives. The remission time in most instances is 4 to 6 months then staying on the extract on a smaller maintenance dosage is important. Success is usually determined by the terminal date. If the patient begins taking the extract 90 days before their approximate terminal date, remission is approximately 50%. If they have six months or longer, then remission and recovery rate can exceed 85%. However, some who have been diagnosed 30 to 60 days terminal are in remission. Children's beneficial response to extract use is usually quicker.

A six month old girl with an inoperable brain tumor 30-60 day terminal the mother stirred one drop of the extract into a glass of milk and spoon fed it to her baby girl over a period of several hours every day. After 90 days the cancer was in remission. A 22 month old girl had cancer of the jaw bone, spine, bone marrow and a lemon sized tumor protruding from her abdominal area. After using 3 drops each day for 4 months, her cancer is now in remission. This infant girl had the maximum of radiation and chemotherapy was 30 to 60 day terminal. A 93 year old woman had cancer of the breast and bone. She took 12 drops each day and her remission time was 8 months. She continues to take a maintenance dosage of 10 drops each day.

Bone Cancer: The toxic inflammation and healing reactions are moderate, but more sever pain can be expected where nerve and large areas of the bone are involved. After the cancer is eradicated the bone calcium mineral loss in those areas will eventually be replaced. The bone replacement process is helped by calcium with boron supplements. Anti hormone drugs and lack of estrogen retards the calcium replacement process. There is no conflict with pain pills, morphine or other medications.

The extract is compatible with chemo therapy and radiation treatments and enhances the efficacy of these treatments. Cancer cells often develop immunity to chemotherapy chemicals. Cancer cells that have metastasized from the site of radiation treatment are not affected by the radiation. However, cancer cells that escape these treatments are eliminated by the extract when it is used before, during and after chemo therapy and or radiation. Also, the chemotherapy/radiation damage to bone marrow and stem cells, fast growing gastro-intestinal cells and other cells are much less when the extract is used in conjunction with these cancer therapies.

Therefore, chemotherapy, radiation, or prescription medications of most kinds, except anti-immune drugs, should not be discouraged when using the herbal extract. Later, as the patient improves, most drugs can be phased out. Operations to remove huge tumors in some instances should not be discouraged. Using the extract before and after the operation will promote more rapid healing and eliminate the cancer cells that metastasize and after operations consequently total remission is achieved sooner. Most breast cancers are eliminated by the extract without resorting to mastectomy.

Those who have had recent operations and have scar tissue, often find that the scars are infected. By using the extract orally the diseased tissue will within 30 to 60 days become swollen, red, and small pus tumors will come to the surface, excrete pus, scab and heal. Breast tumors, cysts, and fibroids, may come to the surface, become red, painful, drain pus, small amounts of blood and other matter for several weeks. Then the diseased area will scab over and heal from the outer edges to the center.

Molecules of the extract pass the blood brain barrier. Consequently most brain disease are eradicated - cancers, pathogens, diseased cells, lesions, epilepsy, dystonia. Other mental disturbances are occasionally corrected. Some reports of reduced depression and improvement of cognitive functioning have been reported. The taking of triple strength lecithin is often beneficial. Certain neuron dysfunctions are not improved. Tests are now in progress with several who have the symptoms of Alzheimer disease. It is too soon to have any progress reports. Perhaps it may stimulate the brains production of acetylcholine which can prevent the formation of beta-amyloid plaques in the brain. The extract for this disease is being used in conjunction with phosphatidyl- choline (triple strength lecithin).

A number of terminal cancer patients who after using the extract continuously for 18 months and their remission was confirmed by their doctors and responsible medical laboratories elected to discontinue using the extract. Some of these have been in remission for more than 5 years and are periodically tested for escalated cancer markers. Their markers have always been normal. Perhaps they develop certain anti cancer immunoglobulins and or memory cells that have given them immunity to cancer? However, most patients who have had serious diseases and are in remission use the extract long term as a preventative. They generally take a daily maintenance dosage of 10 drops daily. (Pathogens or cancer cells do not develop immunity to the extract.)

Some have used the extract continuously for more than 10 years. I have used it continuously for more than 20 years. Most long term users report they don't acquire any new diseases other than an infrequent mild cold or flu that seldom last for more than a few days. They also have less fatigue and enjoy an improved quality of life.

Using the extract as a disease preventative: Beginning nearly 5 years ago clients, who had a family history of cancer but have never had cancer themselves and were in their late 50s through their 90's , commenced a preventative program taking 6 to 10 drops each day. The number of clients in the program has gradually increased to 430 who are presently using the product as a preventative. Some have had mild cases of flu or colds,

but no serious medical problems. If a sore throat or other flu/cold symptoms develop they put 1/2 inch of water in a glass and stir in 4 to 5 drops of extract and gargle. They also increased oral dosage of the extract for a week or 2.

H.I.V., Herpes, Epstein Barr, Shingles, Adenoviruses and Other Virus caused diseases. The extract has an ionic affinity for all viruses and their RNA-DNA particles and retrovirus infected host cells. The extract among other things is toxic to them on contact or by absorption of the extract molecules into the diseased cells mitochondria. Usually within 4 to 6 months the viruses stop replicating. The toxic healing reactions may be nausea, fatigue, slight fever or flu like symptoms. Any previous or present symptoms of the disease may be experienced again or exacerbated for a few weeks, i.e., cold sore, genital herpes, shingles, rashes, hives, etc. An extract enhanced immune system may also play a part in this toxic lysis process.

Ear Infections: Ear infections are reduced or eliminated by using the extract orally for a period of 60 to 90 days. Tinnitus symptoms are diminished or eliminated. Permanent ear damage is not corrected. A few drops of a diluted solution of the extract can be put in the ear to relieve pain and itching (6 drops in a 1/2 a glass of water). Reactions are sometimes more ringing, pain, and itching during the healing process. A four year old had for one and one half years chronically diseased ear, throat, kidneys, and intestinal parasites. Numerous antibiotic treatments did not help. One drop each day for 30 days of the extract eliminated all of the infective.

Infected sinuses: Discharge from nose, or into the throat may be clear, green, or yellow. The infectives are usually reduced or eliminated in 3 to 4 weeks.

Gall and Kidney stones are frequently dissolved in 60 to 120 days.

Hair and pigmentation loss is often caused by alopecia areate (an auto-immune disease), and or herpes, diabetes, anemia, influenza etc. The hair loss is usually reversed by long term use of the extract and proper nutrition. A few have reported that pigmentation returned to their hair. (Perhaps the melanocytes are rejuvenated or stimulated.) In some, excessive skin pigmentations (melanopathy) are reduced.

Minor uses: One drop of the extract used with tooth paste will over a period of time will eliminate gum disease and reduce plaque. Rinse the mouth 10 minutes later. Scalp diseases --Several drops or more in hair shampoo or conditioner, rinse hair 5 to 10 minutes later. Douche -- use 3 to 4 drops per cup of water then hold for a few minutes. Throat gargle --4 to 5 drops in 1/2 inch of water in a glass. Itching skin; apply full strength or dilute with water, lotion or Vaseline. There will be some slight burning. To reduce odors from cancerous tumor lesions -- dilute 10 to 1 and apply to the diseased area. In cases of skin cancer cysts, fungi, warts or other skin diseases, apply topically. However, it is often painful and not usually recommended. Taking the drops orally will eliminate all skin diseases (60 to 90 days) without much pain. The extract often beneficially enhances the efficacy of pharmaceutical medications. Antibiotic agents

work by preventing the growth of bacterial cell membrane. Using the extract in conjunction with antibiotic expedites this process.

**Obesity:** Diseased kidneys, liver, thyroid, blood circulatory problems and other illnesses often cause fluid retention in body tissues. When these and other diseases are eliminated by the extract use the excessive weight is often reduced. Fat cells are not affected by the extract. Follow dosage instructions that accompany the product.

**Oxygen Free Radicals:** The extract is an antioxidant that helps counteract "free radicals" They are highly reactive oxygen molecules that can damage cells throughout the body and promote cancer, premature aging and other health problems. Fresh uncooked fruits and vegetable are rich in enzymes that also help control free radicals. It is advisable to use the extract long term as a preventative (10 drops per day).

Discontinuing the extract or reducing dosage for a few days does not greatly interfere with the toxic healing process. Not taking the extract for seven days or longer usually allows the pathogens and or cancer cells to begin replication again unless the have been previously totally eradicated by extract treatment. Extreme diets that don't include some meat, fowl, fish, and dairy products should be avoided except when following doctor's instructions. The oral use of hydrogen peroxide and Aloe Vera juice counter acts the efficacy of the extract.

Those with extreme nausea, ulcers, and very small stomach cancers may need to start with one drop each day ingested with a suitable liquid over a period of several hours. Dosage should be gradually increased over a period of several weeks. Also it is suggested that vitamins and minerals shouldn't be taken until the nausea ceases and appetite returns. Apricot juice helps reduce nausea and is an excellent liquid to stir the extract into. Some who have a sensitive stomach may need to take a calcium carbonate antacid or supplement a few minutes after ingesting the extract.

**Drip I.V.:** A few health professionals have used the extract in drip I.V.s 1 or 2 drops of the extract is put into 500cc's of what ever solution they select. The diluted drip solution is strained and then used. The patient is closely monitored and the numbers of drops are gradually increased over a period of time. Extreme nausea and stomach pain may be caused by large stomach tumors. In these cases I.V. may be needed.

The herbs that are used in the herbal extract are purchased from organic farms. The roots, stems and flowers are used in the manufacturer of the elixir. The label lists the ingredients. It comes in a 2 Ounce sealed dropper bottle. A bottle will last 3 to 4 months. There is no shelf life it does not require refrigeration or special care.

Much more could be said about the extract however, the least that can be said is that it increases survival time and improves the quality of life.

**Ingredients:** Sanguinaria canadensis, Impatiens pallida, Hydratis canadensis, Ferula galbaniflua, Hypericum perforatum, Rubus villosus, Fumaria officinalis, Fraxinacarinensis, Alliehr, Garlic.  
Trace Elements: Zinc, Potassium, Barium, Iron, Sodium, Calcium, Copper.

**Suggested Use:**

- First day stir 2 drops of extract into any kind of juice or food, and then every day thereafter increase drops by 2 more additional drops until usage is 6 to 12 drops per day.
- Divide drops in equal amounts and take after each meal.
- Maintain this usage for several months or more, or as desired. Then reduce drops to 4 to 6 each day for one year or more.
- Do not take on an empty stomach.
- Drink lots of liquids after taking.
- Maintain traditional nutrition, avoid extreme diets.
- Shake well before using.
- Extract does not deteriorate, lose potency, nor does reasonable heat or cold affect it. It is compatible with any product you may be using. Stains removed by lemon juice or bleach.
